This well presented Park Home is situated on a private and exclusive development of similar dwellings approximately three quarters of a mile from the town centre and adjoining Townsend Nature Reserve at the rear. Amongst the fine features are the views over the town to the Purbeck Hills and Swanage Bay. It is located on an excellent site and has a good sized garden screened by mature shrubs at the rear, which is tiered with a paved terrace and raised lawn section.

Swanage lies at the eastern tip of the Isle of Purbeck delightfully situated between the Purbeck Hills. It has a fine, safe, sandy beach, and is an attractive mixture of old stone cottages and more modern properties, all of which blend in well with the peaceful surroundings.

Tenure: We understand from the owners that the Park Home is currently held on a Mobile Homes Act Agreement. The ground rent and maintenance charge is approximately £780 per annum (payable in two half yearly instalments), which includes site maintenance, water and sewerage. The Mobile Homes Act 2013 gives security of tenure subject to anyone purchasing this property as a permanent home. Interested applicants are advised to consult their legal advisor before submitting an offer.



The entrance hall to this Park Home leads to the spacious L-shaped living/ dining room, which is particularly light with triple aspect and enjoys good views over the town to the Purbeck Hills. The good sized kitchen is fitted with a range of light units, and contrasting worktops and leads to the utility which has plumbing for a washing machine and dishwasher.

There are two bedrooms. Bedroom 1 is a double bedroom with views to the Purbeck Hills, whilst bedroom 2 is a single. The family bathroom completes the accommodation.

The generously sized gardens surround the property, mostly lawned with shrub borders, tiered paved terraces and screened by mature shrubs at the rear. There is an allocated parking space nearby.

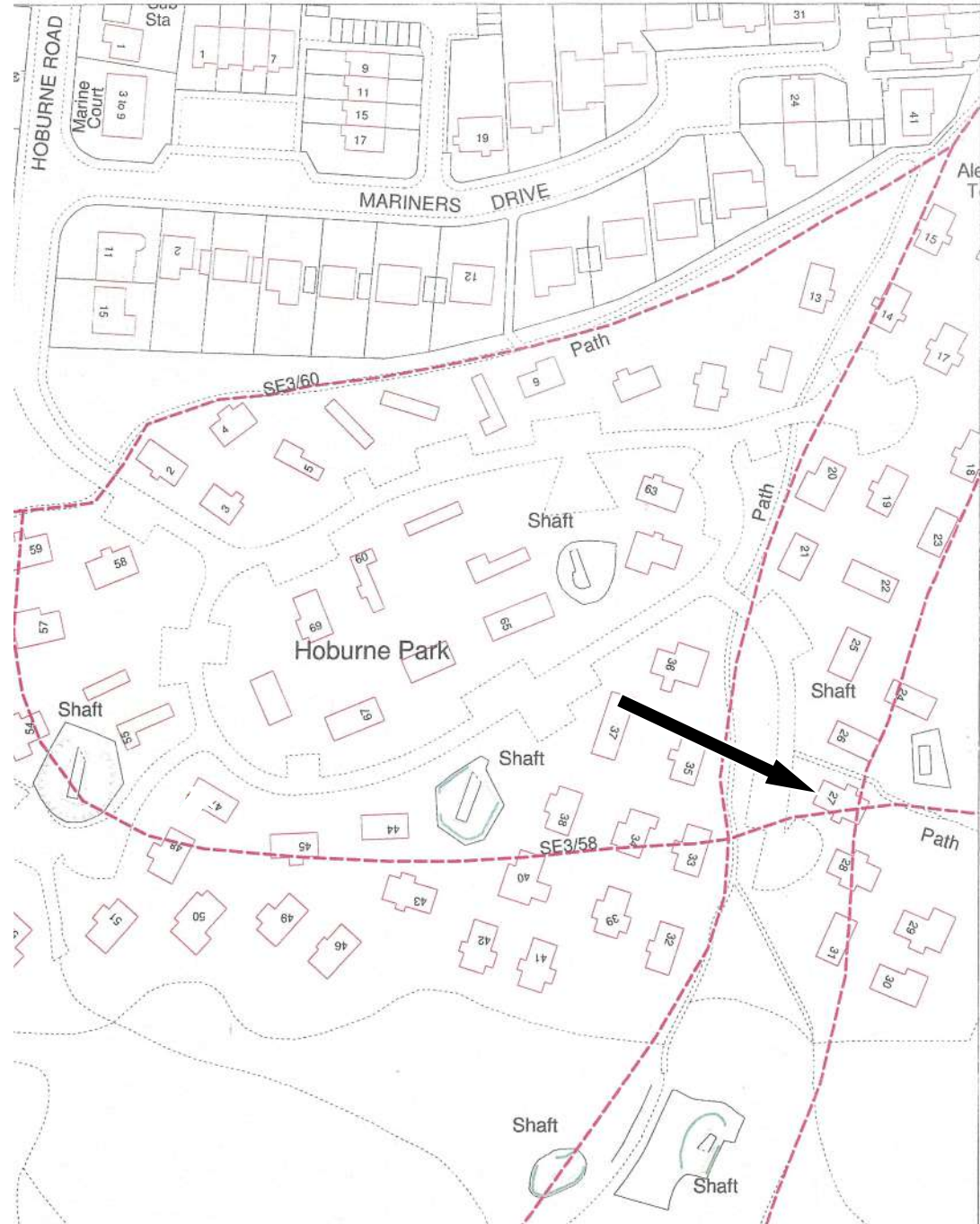
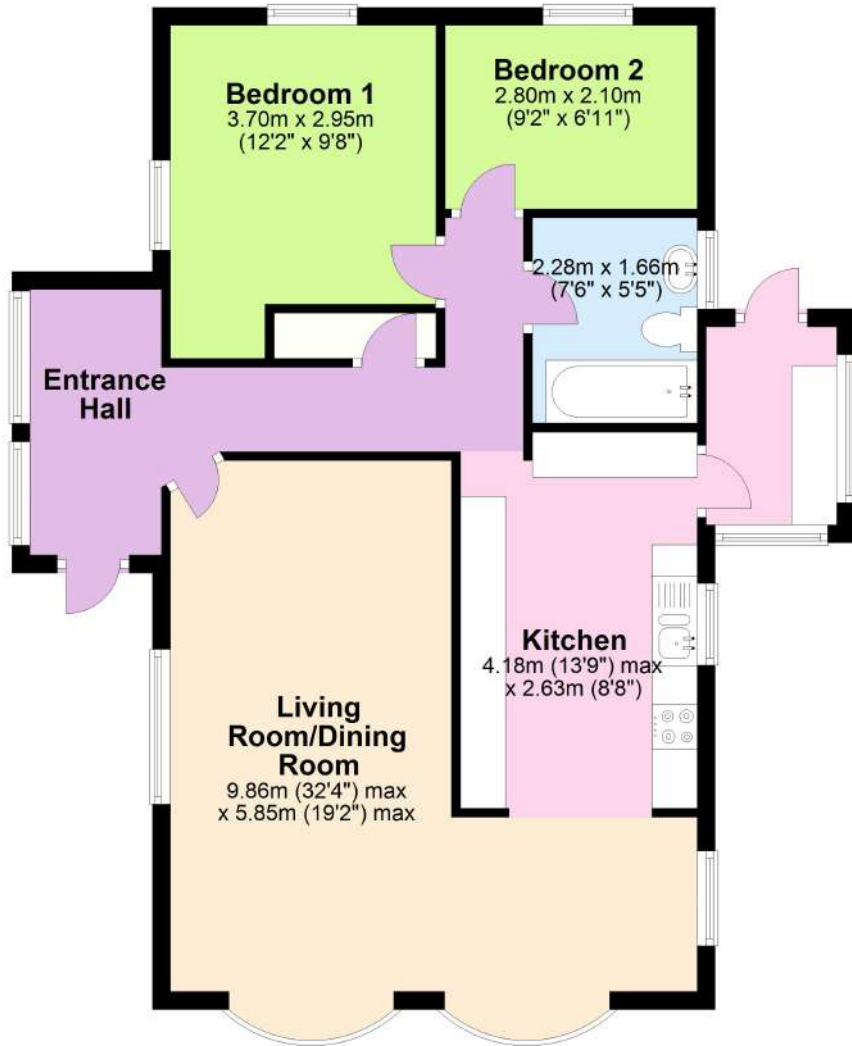
