Offered to the market with no upward chain is this three bedroomed semi-detached property with a single garage and a driveway which is situated in a popular residential location. The property requires general modernisation but does benefit from majority uPVC double glazing and gas radiator central heating. The accommodation briefly comprises entrance hall, lounge, kitchen/dining room, three bedrooms, bathroom, gardens to front and rear, garage and driveway.
