



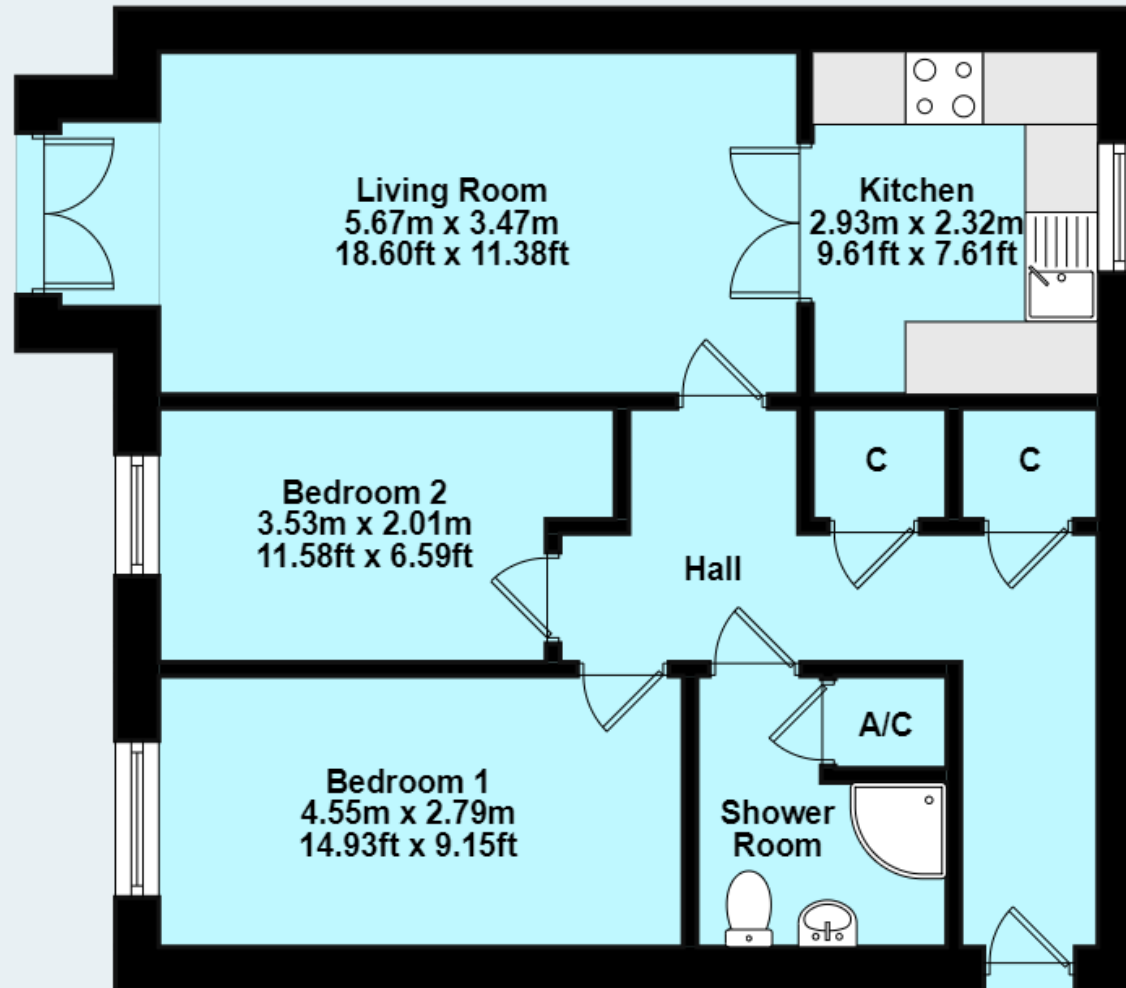

# Description

A two bedroom third floor Retirement Apartment situated within a purpose-built development designed specifically for people over the age of 60. There is also a Hyco instant hot water system in the airing cupboard serving the kitchen and shower room.

The development features a communal lounge and level gardens where residents can relax, The car parking area adds to the convenience of living in this development, with plenty of additional space for visitors.

The large living room has south facing French doors opening to a Juliet balcony affording lovely views of the surrounding countryside and a feature fireplace with electric fire. Double doors open to the kitchen which is fitted with a range of wall and base units, one and half bowl sink and drainer incorporated into work surface with tiled surrounds, electric kick board electric heating, integrated Zanussi electric hob and oven with extractor hood over, space for fridge freezer, space and plumbing for washing machine and window affording views over the

“secret garden” towards North Hill.

Both bedrooms have lovely views towards Dunster and the master bedroom has a built-in wardrobe. There is also a fitted shower room with airing cupboard.
