



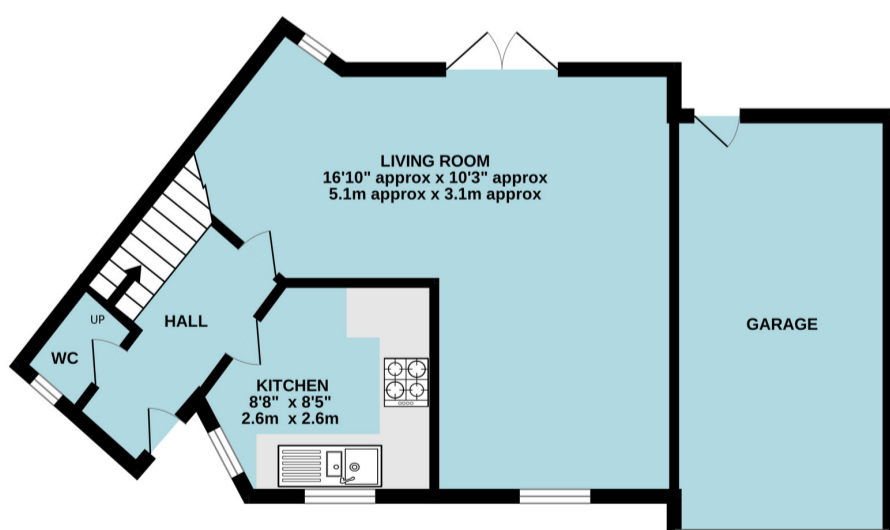

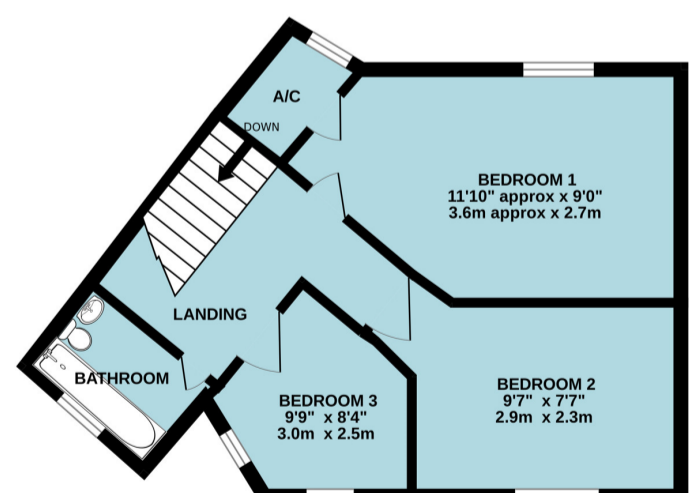

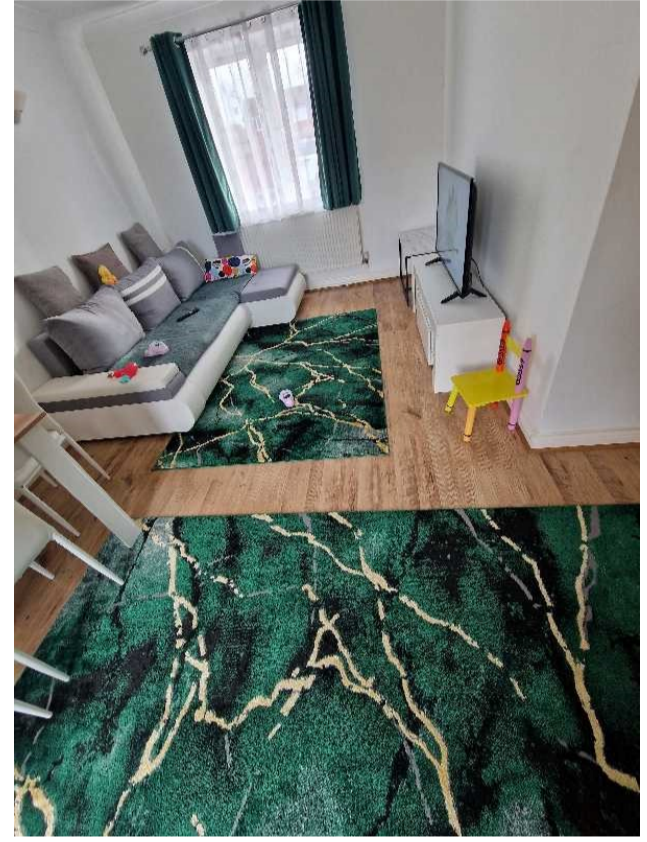
## THE PROPERTY:

The accommodation comprises a door to the entrance hall with a downstairs' cloakroom with a WC, wash hand basin and a double glazed window. The kitchen has a range of high and low level units and front aspect window, gas boiler powering the domestic hot water and the central heating system. There is a L-shaped living room/dining room with patio doors overlooking and accessing the rear garden.

Stairs to the first floor where there are three bedrooms and a spacious airing cupboard to the principal bedroom and a family bathroom with bath, WC, wash hand basin and a double glazed window.

Outside – There is a patio and lawned area which is enclosed and the house benefits from a garage to the front.

**LOCATION:** The property is located on the favoured west side of Bridgwater and is well-placed for primary and secondary schools of high repute. Bridgwater is approximately 1½ miles away with its range of amenities including retail, leisure and educational facilities. Main line railway link is available at Bridgwater Railway Station. There are regular bus services to Taunton, Burnham-on-Sea and Weston-super-Mare plus a daily coach service to London Hammersmith. The motorway M5 junction 23 allows easy access to Bristol, Taunton and Exeter.

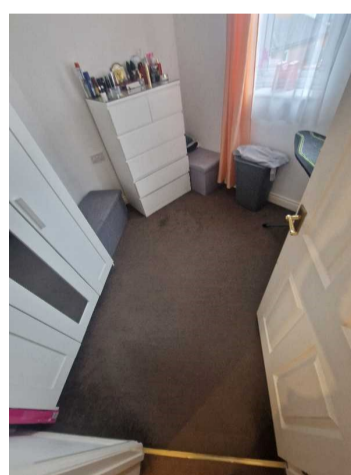
