The Property: The ground floor consists of living room with an open fire, newly fitted kitchen with an integrated dishwasher, electric hob and oven, dining room and WC. Upstairs there are two bedrooms. The bathroom features tasteful décor with a double shower and double ended bath.

Outside: Spacious garden to the side and rear of the property with shed, outbuildings, off road parking.

Services: Property is connected to mains electricity, mains water and drainage with oil fired central heating.

Terms of the Tenancy: The property will be let on an Assured Shorthold Tenancy for an initial fixed term of a minimum of 6 months.

Rent: The rent, exclusive of all other outgoings and Council Tax will be \pounds 995 per calendar month payable monthly in advance by standing order.

Tenancy Deposit: A Tenancy Deposit of five weeks rent will be payable to the Agent on signing the tenancy agreement. This will be held in a government approved deposit scheme by either the Landlord or the Agent.


