### 25 Orchard Way – Bat dusk emergence survey results

Ecoconsult Ltd carried out a dusk emergence survey as indicated as a requirement in comments from the Countryside Officer (South and Vale) in relation to planning application reference: P21/V0679/O.

No bats were recorded emerging from the building during the dusk emergence survey. Please see survey details below.

### Methodology

A dusk emergence survey was carried out on 11<sup>th</sup> May 2021. Three surveyors were positioned around the outside of the building in strategic locations allowing observation of the whole exterior.

Hand-held Anabat bat detectors and Batbox Duet detectors were used. Bat recordings from Anabat bat detectors were analysed using Analook software.

A Helion Pulsar XP38 Thermal Imaging Scope was used as an aid to record bat activity.

#### Weather conditions

The surveys were carried out during good weather conditions. Please see table below.

#### Personnel

# Constraints

No constraints. The survey followed current best practice guidelines with an appropriate level of survey effort, at an optimal time of year and in good weather conditions.

# Results

No bats were recorded emerging from 25 Orchard Way.

Bats observed foraging/commuting during the survey included small numbers of pipistrelle bats.

## Conclusions

The dusk survey has concluded that roosting bats are likely absent from 25 Orchard Way. No further surveys are considered necessary and a Natural England bat licence will <u>not</u> be required prior to works.

Should any bats be discovered during any works (or suspicion arise about the possible presence of bats, for instance in a timber joint, cavity, behind felt etc), that work will cease immediately and a suitably qualified ecologist employed to establish bat presence or otherwise and to advise as necessary.
