Offered with no upward chain is this extended three bedroomed detached house with a south facing garden, single garage and a driveway. The accommodation briefly comprises entrance hall, lounge, kitchen, dining area, conservatory, three bedrooms, shower room, gardens to front and rear, garage and driveway.
