LOCATION

The property is located on King Street in Fenton, close to the A50 dual carriage way. King Street provides a link to Longton to the East, Stoke and Hanley to the West.

DESCRIPTION - Virtual Tour

A useful workshop unit with a manual roller shutter and pedestrian access. Internally the unit is open plan with a 3m eaves height, toilet facility and three-phase electric supply. There is allocated parking for one car and the shared yard is secured by palisade perimeter fencing with a double fenced gate off King Street.

Consideration will also be given to letting the whole site, to include the office at the front and yard to the rear (edged blue).




