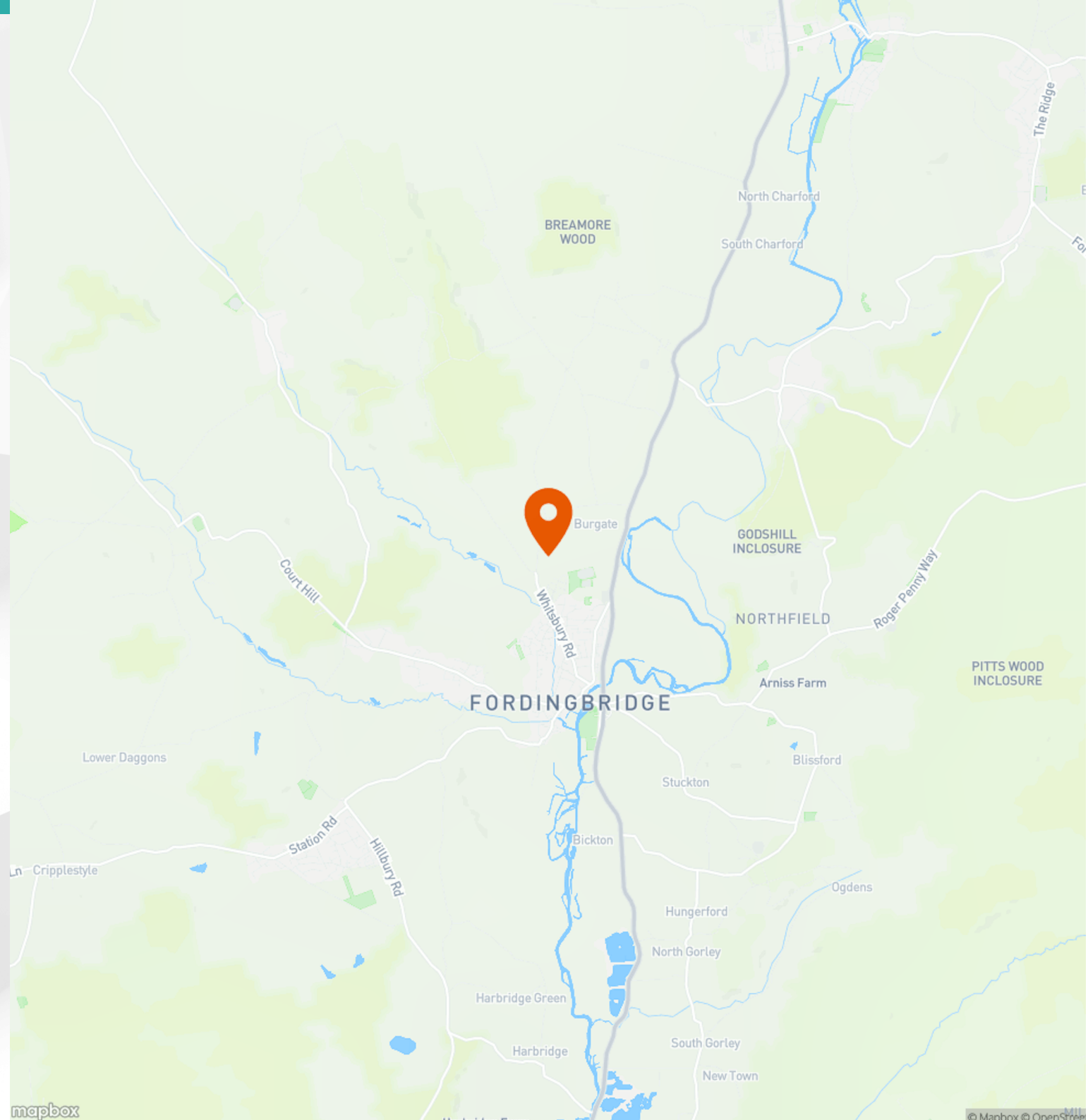


# Location
