

Offered with no upward chain and situated on the southern outskirts of Irthlingborough's 'Pinetree's' estate is this modern two bedroomed end of terraced property featuring a larger than average garden, a generous sized uPVC conservatory and views over Nene Valley with excellent walks to Rushden Lakes Shopping Centre and Stanwick Country Park nearby. Further benefits include gas radiator central heating, uPVC double glazing, refitted luxury bathroom, built in kitchen appliances and offers off road parking for two cars and a single garage. The accommodation briefly comprising entrance hall, cloakroom, kitchen, lounge/dining room, conservatory, two bedrooms, bathroom, front and rear gardens, single garage and a driveway.
