Situated in a cul de sac and walking distance of the Redwell School and shops is this four bedroom detached which requires updating yet benefits from uPVC double glazed doors and windows, built in appliances to the kitchen, gas radiator central heating and a 16ft dining room. The property further offers off road parking, a cloakroom and a south facing rear garden. The accommodation briefly comprises entrance hall, cloakroom, lounge/dining room, kitchen, dining room, four bedrooms, shower room, gardens to front and rear.
