A two bedroom semi detached property which requires some general updating yet benefits from uPVC double glazing, gas radiator central heating and built in kitchen appliances. The property further offers a 16ft kitchen/dining room and a rear garden measuring approx. 61ft in length x 38ft at its widest point. The accommodation briefly comprises entrance hall, lounge, kitchen/dining room, two bedrooms, bathroom and gardens to front and rear.
