LOCATION

Flemington Industrial Park lies to the south east of Motherwell town centre on the southern edge of the major Ravenscraig redevelopment. The industrial park is located within a short distance of the M8 and M74 motorways and is 16 miles from Glasgow and 40 miles from Edinburgh. Additionally, a regular rail service to Glasgow Central Station operates from Shieldmuir Station which is close-by.

The park is accessed directly from the A721 and also via Craigneuk Street and Wellington Street.

DESCRIPTION

Flemington Industrial Park is a self-contained site and comprises a range of industrial units and storage yards of various sizes. The buildings are generally of traditional brick and steel construction and the yards are covered in tarmac or hard standing. A schedule of current availability is listed below.

The park benefits from 3 phase electricity and a 24-hour CCTV system with some units capable of incorporating cranes.
