Location

Located on Simeon Street, the property is just a short walk from the Town Centre, the Esplanade and Ryde's extensive sandy beaches.

The unit enjoys a prominent corner position which benefits from a high foot fall with walkers, locals and tourists alike.

Ryde is the biggest town on the Island by population, circa 32,000 (2011 census) and offers great transport links across the Island with Ryde Pier housing the Fastcat to Portsmouth.

Description

Offered for sale is Madeira, a well-known trading antique store and coffee shop.

The unit benefits from large dual aspect windows and measures approximately 50 sqm. The ground floor consists of retail space, a coffee bar & seating area with a tanked, well-kept basement to the lower ground floor and a separate WC.

The current owner has a café license for 35% of the shop which generally consists of approximately 15 covers and have previously served cold food such as cakes and sandwiches.

All items in the shop will be included in the sale, including the Fracino coffee machine and ICR till.

Services

The unit benefits from mains electricity, water, and drainage.









Ground Floor
