Unit 4D comprises an open plan studio with plentiful character, including herringbone timber flooring, beautiful pitched roof with industrial style pendant lighting, original Crittal windows and a large loading door flooding the space with natural light.

Location

Printing House Yard is an attractive cobbled estate, popular with creatives located in the centre of Shoreditch, surrounded by many shops restaurants and bars. Shoreditch High Street Station is a short walk from the office and Old Street Station is under a ten-minute walk, giving easy access to the Northern Line and National Rail services. The development attracts a mix of occupiers including architects, fashion designers and creative agencies.

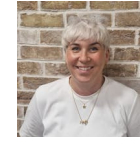
