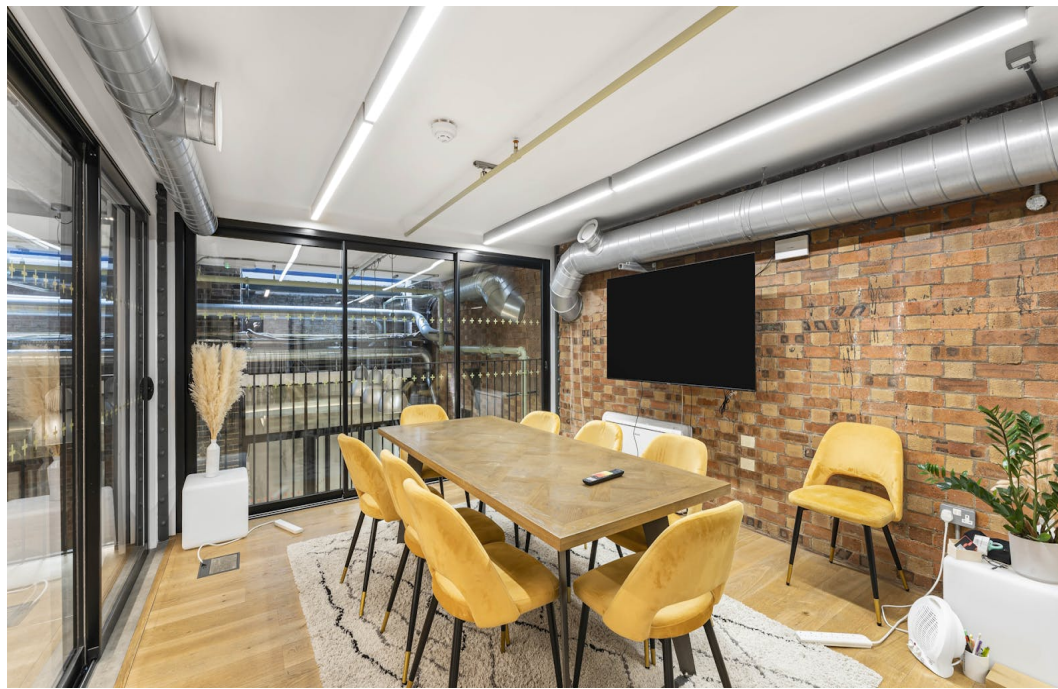
Location
