

If you're searching for a modern four bedroomed detached house with a stunning open plan kitchen/dining room with quartz work surfaces and built-in appliances - this might be the one for you! Situated at the end of Larkin Gardens in a small cul-de-sac, this property enjoys a south facing rear garden, single garage, off road parking, ensuite shower room, uPVC double glazing and gas radiator central heating. The accommodation briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, utility room, four bedrooms, ensuite shower room, family bathroom, rear garden, garage and driveway.

Radiator, built-in cupboard, stairs rising to first floor landing, under stairs storage cupboard, doors to:

Comprising low flush W.C., wall mounted wash hand basin, tiled splash backs, radiator.

#### Lounge

Bay window to front aspect, radiator, coving to ceiling.
