GENERAL DESCRIPTION

Loch Ettrick is a beautiful, tranquil Loch located in the heart of the Forest of Ae about 17km North of Dumfries.

The property consists of the Loch (7.3 hectares), a separate pond, surrounding wooded banks, the dam and the old boat house. There is a good vehicle track across the dam to the boat house and access along the Loch shores.

The boat house requires renovation but has excellent potential for "off grid" recreational use.

The Loch has been used as a stocked Trout Loch in the past and fish are still present.

TENURE AND POSSESSION

The property is offered for sale freehold with vacant possession upon completion.

ACCESS

There is good and easy access via minor public roads from the A701 via Ae village to the East or from the A76, near Thornhill to the West.

The buyer will be held to have satisfied himself or herself on all such matters.




