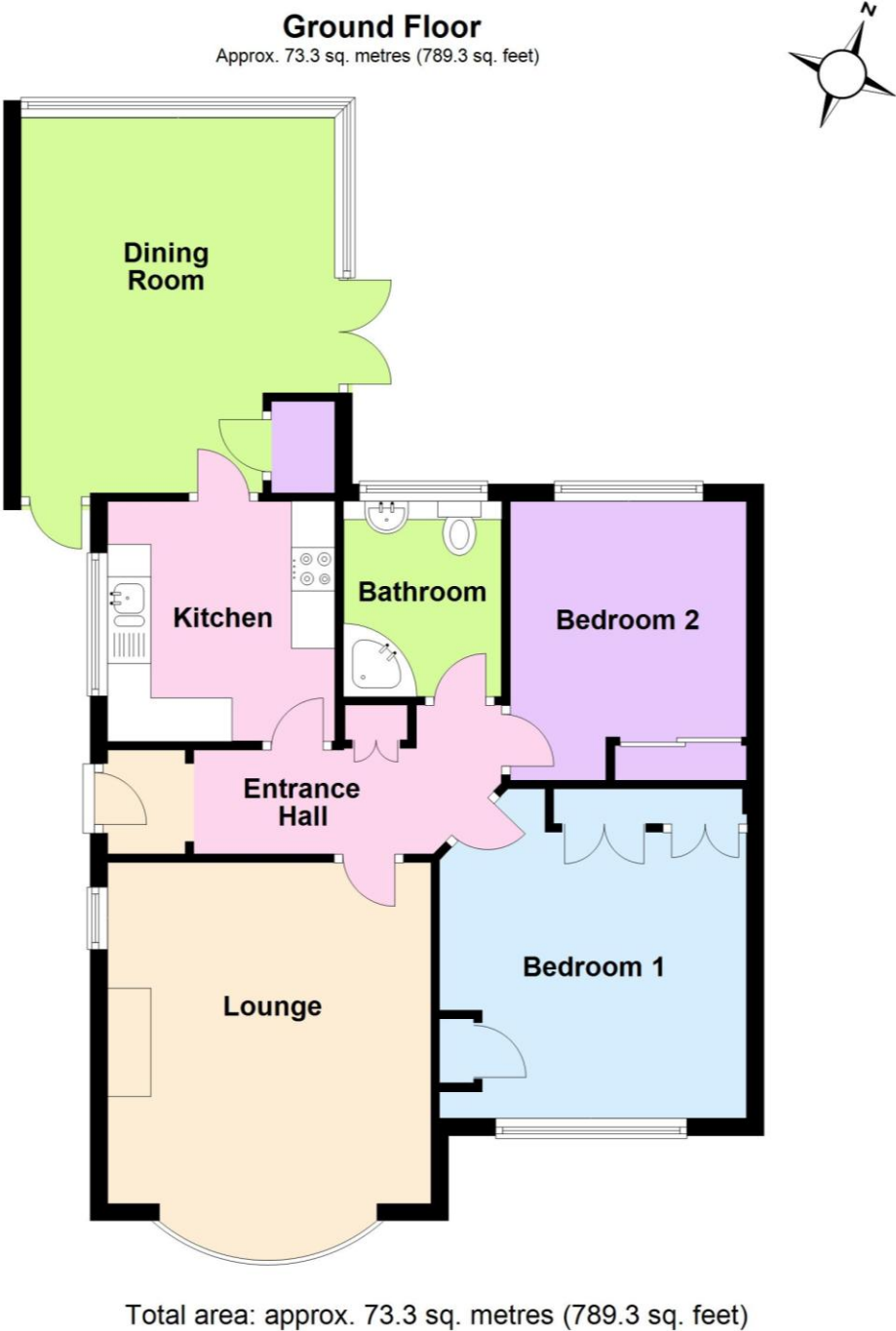

Your solicitor will also agree with the seller what items (e.g. carpets, curtains etc) will be included in the sale.

Offered in immaculate condition throughout is this two bedroom semi detached bungalow which is located in the popular residential area of The Pyghtle. Benefits include a refitted kitchen with a range of built in appliances, uPVC replacement doors, windows, fascia and soffits, a refitted bathroom and gas radiator central heating. The property further offers off road parking, built in wardrobes to both bedrooms and a 13ft x 11ft separate dining room. Viewing is highly recommended to appreciate the condition of the property. The accommodation briefly comprises entrance hall, lounge, two bedrooms, bathroom, kitchen, dining room and gardens to front and rear.

Bathroom

Comprising corner bath with shower over, low flush W.C., wash hand basin set in vanity unit, obscure glazed window to rear aspect, tiling to walls, extractor fan, towel rail, tiled floor.

Kitchen

Comprising one and a half bowl single drainer stainless steel sink unit with cupboards under, range of base and eye level units providing work surfaces, built in electric oven and gas hob with extractor fan over, integrated dishwasher, washing machine and fridge/freezer, window to side aspect, downlights to ceiling, laminate floor, door to.

Rear - Wooden decking area, steps to lawn, various shrubs, plants and bushes, wooden shed, enclosed by panel fencing, pedestrian gated access to front.
