

Description

A well presented one bedroom coach house with the added benefit of a larger than average garage, parking, gas fired central heating and enjoys close proximity to the Hinkley bus stop/route. The property includes a well fitted kitchen with a built-in oven, hob and hood together with a white bathroom with shower over the bath. It is offered to the market with no onward chain.

THE PROPERTY:

The accommodation comprises a communal front door into an entrance hall where stairs rise to the first floor landing. From here the front door opens into the entrance hall which has a useful airing cupboard. The living room is well proportioned and bright and airy having two windows cascading natural light. Off is a kitchen with a range of base and wall cupboards and rolltop working surfaces. There is a built-in oven, hob and hood. Finally, is a double bedroom and a bathroom.

Outside – Is a car parking area/driveway with allocated parking which leads to the garage.

LOCATION: The property is situated on the popular north-west side of the market town of Bridgwater close to junior and senior schools of high repute. The town offers a range of amenities including retail, educational and leisure facilities. The M5 junctions 23 and 24 are nearby along with mainline links via Bridgwater Railway station. There are regular bus services to Taunton, Weston-super-Mare and Burnham-on-Sea plus a daily coach service to London Hammersmith from Bridgwater Bus Station.
