Offered with no upward chain is this three storey four bed roomed bay fronted mid terraced property which offers generous accommodation including three double bedrooms. Inside you'll also find a 25ft lounge/dining room, ensuite W.C. to the second floor bedroom, uPVC double glazing and gas radiator central heating (although the boiler does require replacement). Outside there is a courtyard style garden with brick outbuilding. The accommodation briefly comprises lounge/dining room, inner hallway, kitchen, three bedrooms and bathroom to the first floor, bedroom and W.C. to the second floor, gardens to front and rear.

Bay window to front aspect, feature open fireplace, radiator, through to:

Feature fireplace, French door to rear aspect, radiator, through to:

Comprising stainless steel one and a half bowl single drainer sink unit with cupboard under, a range of eye and base level units providing work surfaces, built-in oven, gas hob, extractor hood, tiled splash backs, window to side aspect, wall mounted gas boiler serving domestic central heating and hot water systems (please note: we have been advised by the seller of the property that the boiler requires replacement and is not currently working), airing cupboard housing hot water cylinder, space for under counter fridge.

Front - Small fore garden enclosed by low brick walling.

Rear - Courtyard style garden with wooden summerhouse, brick outbuilding, brick store with plumbing for washing machine and work surface, enclosed by wooden fencing and brick walling with gated side pedestrian access.
