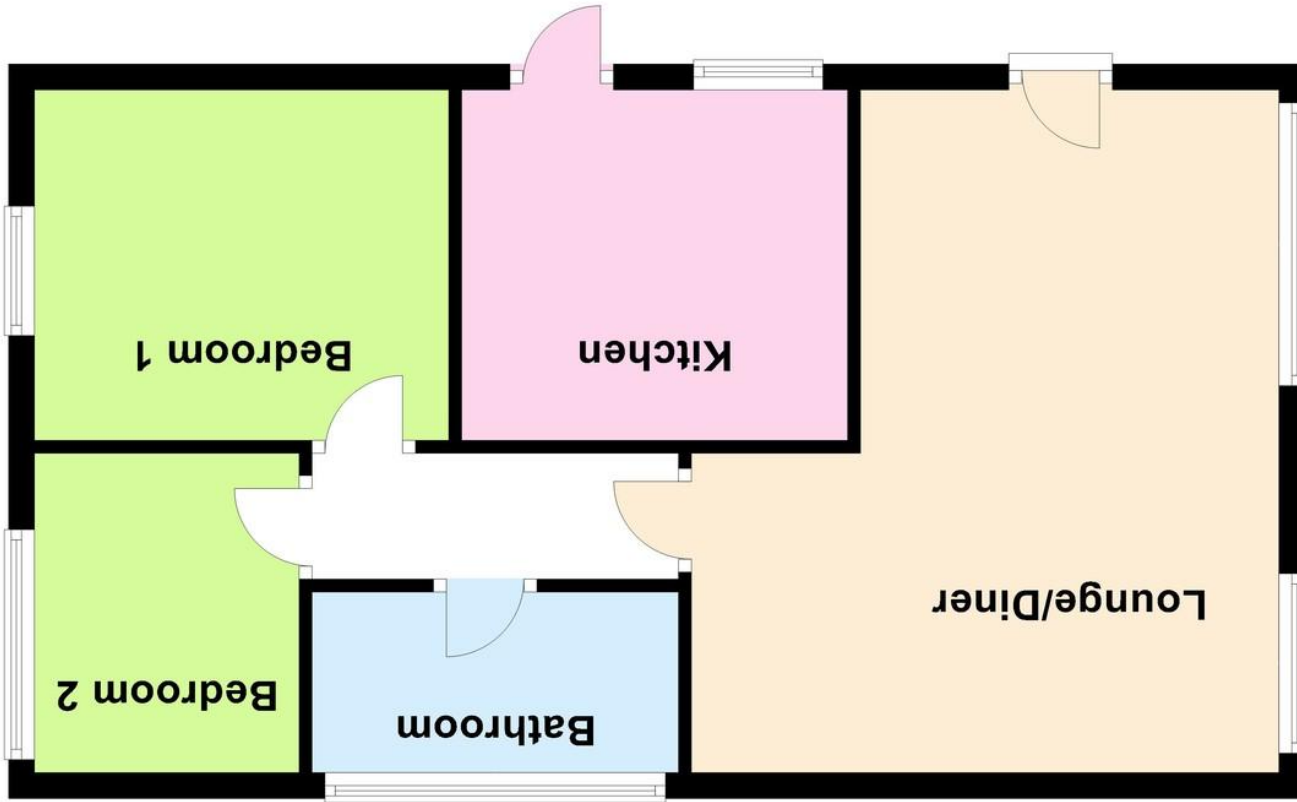

Property Description

Having side garden with paving, garden shed with power housing tumble dryer, steps leading up to the property and front door into:-

LOUNGE 7' 6" x 10' 6" (2.29m x 3.2m) 10' 4" x 10" - with double glazed windows to front, radiators.
