EXTERIOR

SITUATION

The property is situated in a rural area just outside of Southborough Common. The area is generally well favoured with good educational facilities including Southborough primary school and good secondary/grammar schools in St Johns Road. The larger towns of Tunbridge Wells and Tonbridge are each about 2 miles distant offering a wide range of multiple shopping, leisure and recreational facilities, together with mainline stations providing fast and frequent train services to London Bridge, Charing Cross and Cannon Street. The property is superbly located for access onto the A21 dual carriageway which provides a direct link to the M25 London orbital motorway. Recreational facilities in the area include the Tunbridge Wells Sports & Indoor Tennis Centre in St Johns Road and out of town there is the Knights Park Leisure Centre which provides a tenpin bowling complex, a multiscreen cinema and a private health club.
