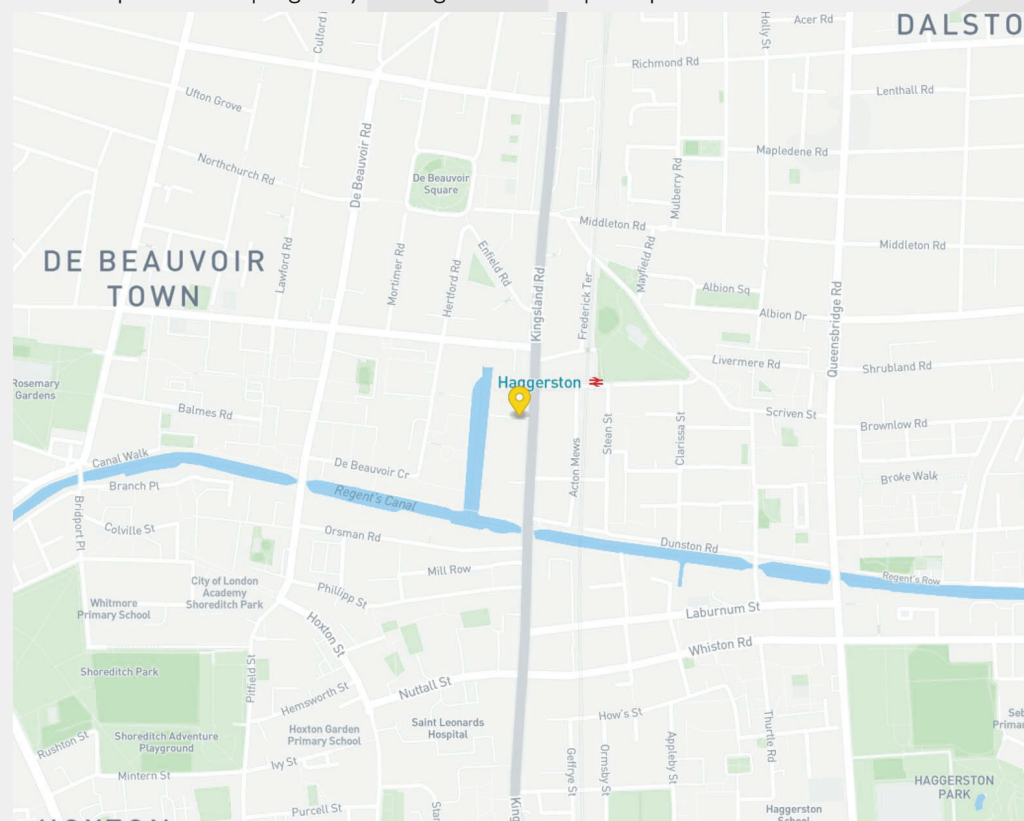


Description
