


Description

Arranged over lower ground to 5th floor, this fully self-contained 7-storey building offers prominent frontage onto Gray's Inn Road and Brownlow Mews with the main step-free access provided from Grays Inn Road. The building benefits from two stair cores to the rear of the property, both of which provide separate direct access onto Brownlow Mews. An elevator serves all floors from the main core. The building would look to suit any uses within Class E (office, medical, retail and leisure) as well as scope to reinstate Class F1 (education/training).

Location

Gray's Inn Road is a renowned address and the building is located on the western side of the main road, which runs north to south through the heart of Bloomsbury, connecting King's Cross in the north to High Holborn in the South. Farringdon Station (The Elizabeth Line, Thameslink, Circle, Hammersmith & City and Metropolitan lines) is a 15 minute walk away.
