

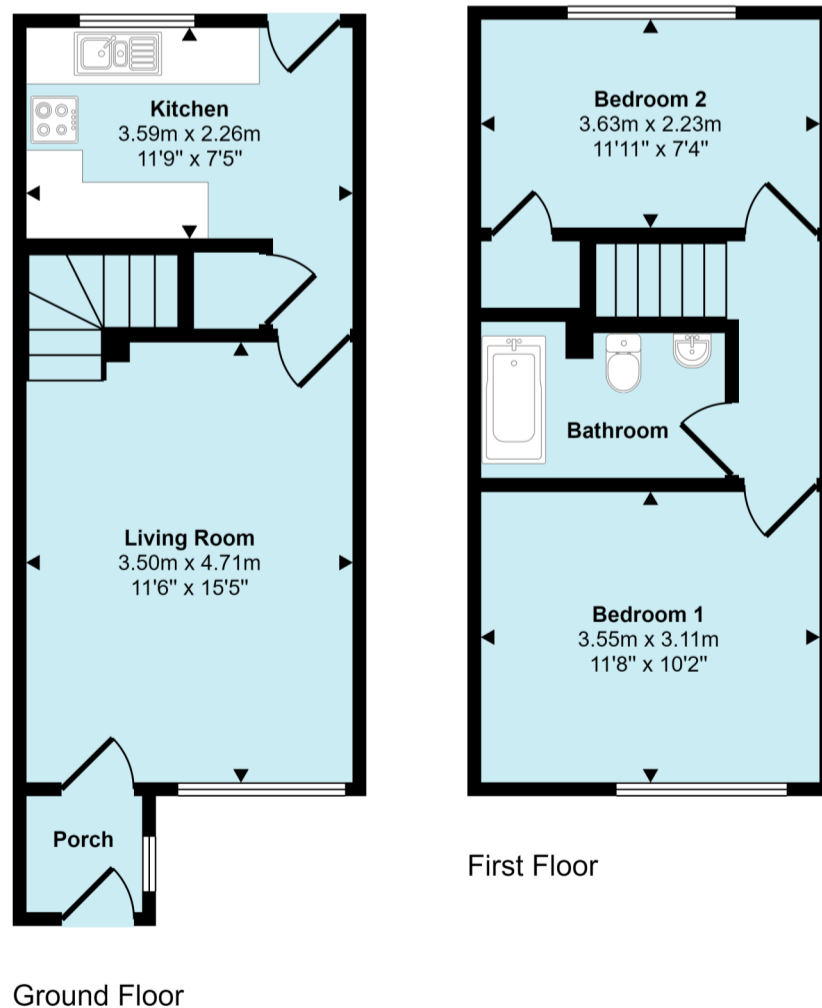

Description

This two bedroom modern house benefits gas fired central heating, off-road parking for two vehicles and private enclosed garden to the rear.

The property is situated a level walk from the town centre and is close to Cranleigh Gardens with its park and play area.

THE PROPERTY:

The accommodation comprises a door to the entrance porch, a living room with stairs to the first floor landing and wooden effect flooring. There is an inner lobby with understairs' storage cupboard, a kitchen fitted with a range of high and low level units, gas boiler powering the domestic hot water and the central heating system, plumbing for a washing machine and an extractor hood for the cooker along with recesses for domestic appliances and a double glazed rear door.

To the first floor are two good size bedrooms and a bathroom – with WC, bath, shower over and a wash hand basin.

Outside – To the front is a paved area and to the rear is a patio with a garden laid to lawn, enclosed by fencing with a footpath leading to the garden shed and off-road parking for two vehicles.



LOCATION: Sandpiper Road is situated on the select Blakespool Park Development, which is known for its good access to the town centre along with its location being positioned next to Cranleigh Gardens where many recreational pursuits can be enjoyed. The town centre of Bridgwater is within walking distance and enjoys a wide range of shops, educational facilities, a cinema, a library and easy access to the M5 motorway via junctions 23 and 24. The mainline railway station is also within walking distance.
