The property is situated opposite the junction with Trinity Road and is a short distance from Oxford Street (A41 trunk road) and the Black Country Route (A463) which ultimately leads to Junction 10 of the M6 approx 4 miles distant.

Situated at the rear of the site and approached via a shared concrete driveway from Hare Street to a gated loading and concrete surfaced car park area

DESCRIPTION

Comprising a single storey steel framed warehouse with solid floor and blockwork and brick walls, with dual pitched part lined profile composite clad roof and part asbestos with translucent panels on steel trusses with LED lighting. Works offices.

The unit has min eaves of 3.3m min. Access to the warehouse is via a roller shutter door.

All mains services are available except gas. Offices are heated by an LPG boiler and gas tank Boiler needs replacement.


