Anderson Hall is a former village hall in the small commuter village of Dornock. The village provides easy access to the M74 and local towns for shopping, schools and other amenities. The property was formerly used by the local community before being bought by the current owners.

The Accommodation

The front door opens into an entrance hall giving access to two toilet blocks and an inner hallway. From here, access is given to a large, well lit, room which has been used as a badminton court in the past. The views to the rear from this space are exceptional, looking out to open fields with the coast in the distance. A further room can be accessed through bi-fold doors or from the inner hallway, creating a versatile space ripe for conversion subject to necessary consents. Both rooms have part timber pannelled timber walls and solid wood floors.

Externally, a three metre strip of field to the left side (facing from the road) and rear of the property are included, together with a larger area to the right which could be developed into a garden, off road parking or garage space, all subject to necessary consents. There is currently off road parking to the front of the property. The exact boundaries will be confirmed at point of sale, but the included site plan gives an indication of the likely boundaries.

Situation

The property is located in a popular location around 2.5 miles from the charming town of Annan in Dumfries and Galloway. Annan is known for its welcoming community, rich history, and scenic surroundings, offering a blend of rural beauty and convenient town living. For commuters, Annan railway station is just a short drive away, providing regular services to both Carlisle and Glasgow, making it ideal for those who travel for work or leisure. The nearby A75 provides easy road access to the M74, connecting to major cities across Scotland and Northern England.
