



Making an ideal first time purchase is this well presented three bedroomed mid terraced property which was built in 2019 by Taylor Wimpey Homes and features off road parking for two vehicles and multiple built-in kitchen appliances. Further benefits include a rear garden with wooden decked area, built-in wardrobes to bedroom one, gas radiator central heating and uPVC double glazing. The accommodation briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, three bedrooms, bathroom, gardens to front and rear and a driveway.

Rear - Patio area, lawn, raised beds with decorative gravel, wooden decked area, outside tap, outside light, outside electric points, enclosed by wooden fencing with gated rear pedestrian access.
