We are delighted to present this Victorian semi-detached four double bedroom family home, offering spacious accommodation over three floors and set in a quiet road close to Southborough common and local amenities.

### **ACCOMMODATION**

This Victorian semi-detached family home is situated in a highly desirable location in an area known as the "South of France" being close to Pennington Park and a few moments walk from the beautiful Southborough common and cricket ground as well as local shops and amenities.

Set over three floors the property is light and airy throughout and has an abundance of character and charm, as well as being contemporary in its presentation. The sitting room is a good size and has an easterly facing bay window along with a fully working open fireplace. The dining room is set to the rear of the property, has large understairs storage and is open to the kitchen which is fitted with a lovely range of grey shaker style cupboards with a contrasting worksurface. There is a utility room which has a washing machine, fridge/freezer and this in turn leads to the modern bathroom.

On the first floor you will find the principle bedroom with its triple bay window and feature fireplace as well as a further double bedroom set to the rear of the house which also has a feature fireplace and a built in wardrobe. There is also a WC located on this floor.

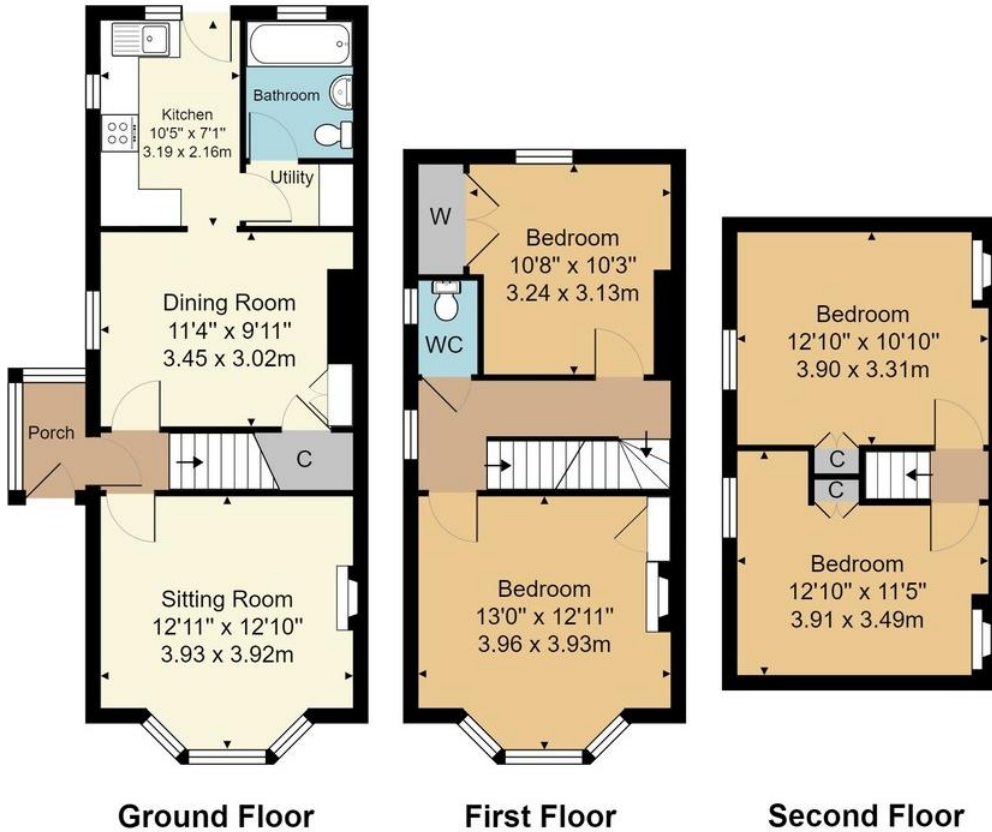
The top floor is home to two further double bedrooms, both with built in storage and feature cast iron fireplaces.

### SITUATION

The property is ideally situated in a popular residential part of Southborough close to local shops, bus services with good access to local schools, many within walking distance and a wide range of amenities. The area is well known for its close proximity to many well regarded primary, secondary and grammar schools. Tunbridge Wells and Tonbridge town centres are respectively 1.7 miles and 2.6 miles distant offering a wider range of shopping facilities. Mainline stations are located in both towns as well as in High Brooms, 0.9 miles away and all offer fast and frequent train services to London & the South Coast. The property is also situated for access onto the A21 which provides a direct link onto the M25 London orbital motorway. The area is also well served with good recreational facilities including Tunbridge Wells Sports and Indoor Tennis Centre in St Johns Road and the out of town Knights Park Leisure Centre which includes a tenpin bowling complex, multi screen cinema and private health club.
