Description

This is a great opportunity to secure a restaurant/bar in central Hoxton. The unit has a good current level of fit-out with fitted kitchen and bar areas. The units also benefit from rear loading.

Annual rent is £45,000 per annum, with a seven-year renewable lease term (expiring April 2031), and a tenant only six-month break clause, the next rent review is in April 2028. The new tenant will need to provide a three month rent deposit and rent will be due quarterly in advance. The lease assignment is subject to a premium of £75,000. We have been advised rent is not subject to VAT.

The licensing hours comprise: 10am to 11pm - Sunday to Thursday and 10am to 12am Friday to Saturday. The Landlord for this property is the London Borough of Hackney.

Location

100-102 Hoxton Street is located at the southern end of Hoxton Street - close to the junction with Falkirk Street. Hoxton and Shoreditch remain established hubs for the restaurant and bar sector. Hoxton, Shoreditch High Street and Old Street Stations are all within walking distance of the unit and various bus routes can be easily accessed from Old Street which is 5 minutes walk.
