- 1. To be let on an Assured Shorthold Tenancy for a minimum term of at least 12 months.

- 3. Each applicant is required to complete an application form to apply for a property. An application is not deemed as put forward until ALL applicants have returned a fully completed form to the agent.
- 4. References will be obtained using a credit reference agency.
- 5. The holding deposit is the equivalent of 1 weeks rent payable to reserve a property.
- 6. The holding deposit can be retained by the agent/landlord in certain circumstances if the tenancy does not go ahead as outlined within Schedule 1, Tenant Fees Act 2019.
- 7. The Bond (security deposit) is the equivalent of 5 weeks rent payable in cleared funds at the commencement of the tenancy.
- 8. The property will be withdrawn from the market pending referencing and right to rent checks as soon as an application is provisionally accepted by the landlord and a holding deposit has been paid.
- 9. Right to rent checks will need to be completed in person at our offices.
- 10. The holding deposit will be used as part of your first months rent payment if the application comes to fruition.
- 11. The deadline for agreement is 15 calendar days from the date the holding deposit is received by the agent.
- 12. The move-in date must be no more than 30 days after payment of the holding deposit. The move in date will be agreed at the application stage.
- 13. Before moving in to a property payment of the first months rent and bond must be made in cleared funds.
- 14. Tenants are responsible for any permitted payments if applicable throughout the tenancy.
