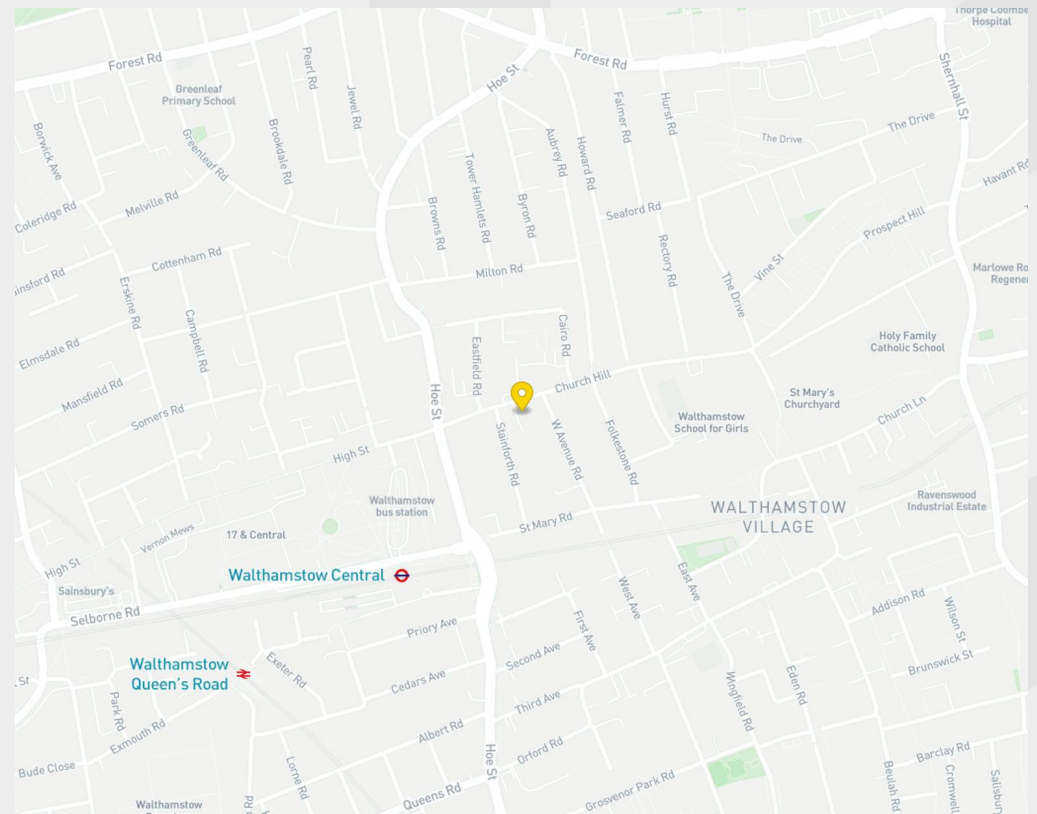


## Description

Occupying the ground floor of a part 6, part 7 storey mostly residential building, opposite popular local landmarks such as Central Parade and adjacent to the main entry point to the High Street and Walthamstow Market. The market, which stretches for a kilometre and dates back to 1885, is home to around 500 stalls which offers a farmers market at weekends.

## Location

Situated on the south side of Church Hill, in a prominent corner position at the junction with Hoe Street and High Street Walthamstow. Walthamstow Central Station is within a short walking distance as well as offering bus route connections to Chingford in the North and Leyton/Bakers Arms to the South. There are good road links to the A12, M11 and A406 North Circular Road for delivery and servicing.
