Location

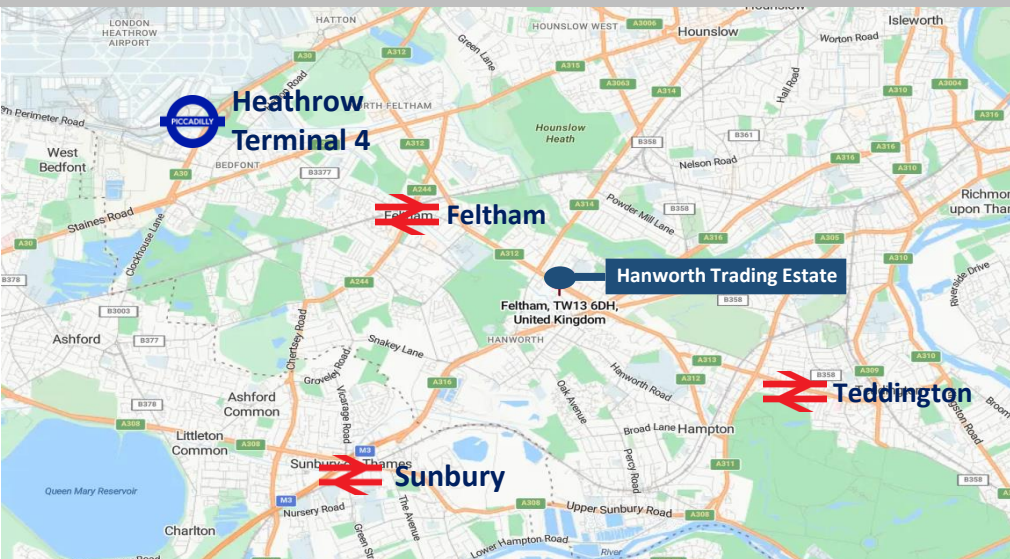
The site is located within the Hanworth Trading Estate, off Hampton Road West (A312) which connects with A316 which adjoins M3, circa 2 miles south.

Hanworth Road West leads north to Feltham and Heathrow Airport, being circa 4 miles to the north west. Central London is situated circa 13 miles north east via the A316.

The Site

The property features a storage compound surfaced with tarmac, enclosed by steel palisade fencing and equipped with security lighting.
