ACCOMMODATION

Ground Floor:

Entrance leading into the hallway with a door leading into the downstairs WC. Door from the hallway leads into a good sized Lounge with wooden effect flooring. The modern bright Kitchen has plenty of storage with a range of wall and base units for storage, an integrated oven with extractor hood above integrated fridge freezer, dishwasher and washing machine. The kitchen also boasts a lovely modern island with cupboards.

First Floor:

From the stairs you have the Family Bathroom with a white suite including a bath with a mixer tap and shower attachment, separate shower, wash basin and W/C. The Master Bedroom is good sized double overlooking the back of the property with an ensuite shower room. Bedroom 2 and 3 are also good sized Double Bedrooms with Bedroom 4 being a smaller Bedroom/study space.

OUTSIDE

To the rear there is a paved patio garden and steps leading down to a shared drive with 2 allocated parking spaces.
