Offered with no chain and situated just off Gainsborough Drive is this four bedroom detached property which has been modified and now boasts an impressive 21ft max x 15ft max refitted kitchen/dining room with an extensive range of built in appliances. Benefits include a refitted ensuite shower room, a refitted bathroom, uPVC double glazing, gas radiator central heating and a burglar alarm system. The property further offers a 21ft lounge. Viewing is highly recommended. The accommodation briefly comprises entrance hall, kitchen/dining room, cloakroom, lounge, ensuite shower room to master bedroom, three further bedrooms, bathroom, gardens to front and rear and a single garage.
