Situated in one of Irthlingborough's most popular residential areas is this deceptively spacious mature bay fronted three bed roomed semi detached property featuring a generous sized rear garden measuring in excess of 100ft in length and off road parking for up to six cars! Further benefits include gas radiator central heating, uPVC double glazing, built in kitchen appliances and offers separate reception rooms, three double bedrooms and large bathroom measuring 10ft x 11ft max. The accommodation briefly comprises entrance hall, cloakroom, lounge, dining room, kitchen, landing, three bedrooms, bathroom, rear garden and a driveway.
