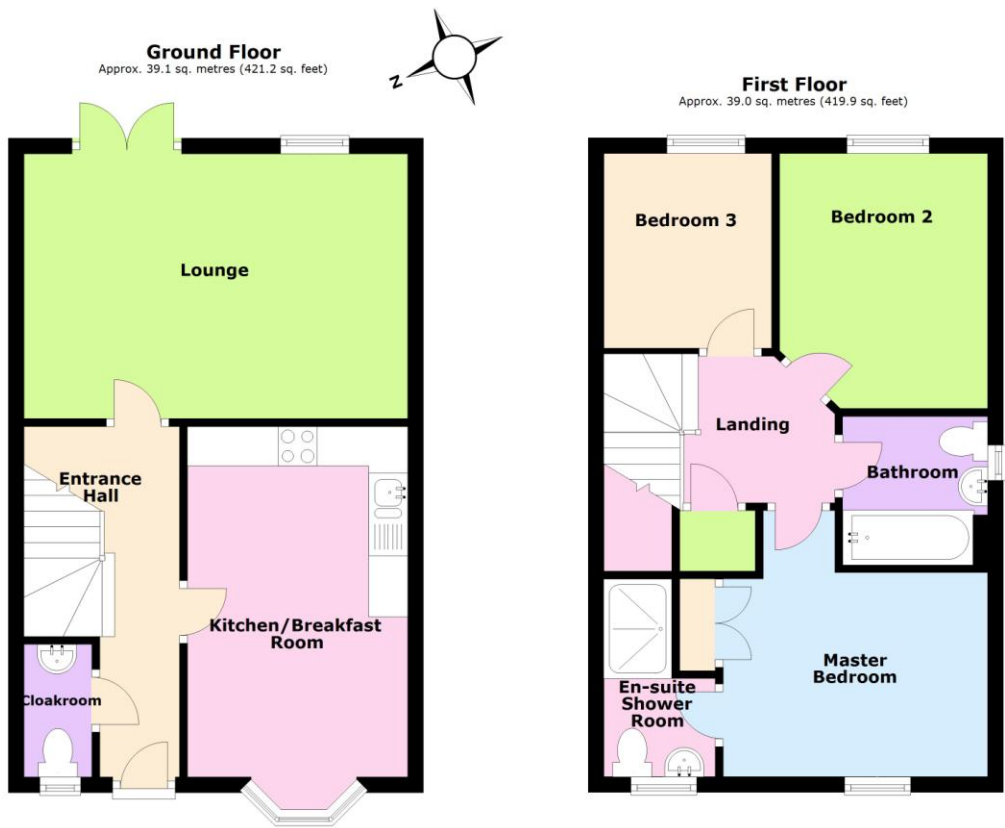

Situated in a cul de sac on the northern outskirts of Irthlingborough and constructed in 2014 by Persimmon Homes is this very well presented three bedroomed semi detached property with benefits to include uPVC double glazing, gas radiator central heating, built in stainless steel kitchen appliances and offers off road parking for two cars. The accommodation briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, three bedrooms with en suite shower room to master, bathroom, front and rear gardens and a driveway.

Two piece suite finished in white comprising of pedestal hand wash basin with tiled splash back, low flush W.C., radiator, tiled flooring, window to front aspect.

Rear - Comprising paved patio, main lawn with raised border stocked with shrubs, wooden summer house, gated side pedestrian access, garden is enclosed by wooden panel fencing.

Driveway - Providing off-road parking for two cars, also note on the driveway there is a outside power point.
