Situated within a short walk of the railway station is this three bedroom end terrace property that benefits from uPVC double glazing, gas radiator central heating, a 14ft kitchen with built in appliances and a refitted shower room. The majority of the flooring has been replaced with wooden flooring and the rear garden is attractively laid. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, three bedrooms, shower room and rear garden.

Enter via entrance door with obscure glazed insert to.

Window to rear aspect, radiator, exposed brick chimney with inset tiled hearth, wooden flooring, through to.

14' 9" x 8' 4" (4.5m x 2.54m) (This measurement includes area occupied by the kitchen units)

Comprising white ceramic single drainer sink unit with cupboards under, mixer tap, range of base and eye level units providing work surfaces, tiled splash areas, built in electric oven, gas hob with extractor hood over, plumbing for washing machine, plumbing for dishwasher, space for fridge/freezer, radiator, gas fired boiler serving central heating and domestic hot water, understairs storage area, wooden flooring, window to rear aspect, window to side aspect, door to rear garden.

Window to rear aspect, radiator, part ornate mouldings to one wall, coving to ceiling, wooden flooring.

**Bedroom Three**

8' 5" x 6' 8" (2.57m x 2.03m)

Window to rear aspect, radiator, wooden flooring.

**Shower Room**

White suite comprising double width walk in shower, pedestal hand wash basin, low flush W.C., tiled walls, tiled floor, chrome effect towel radiator, electric extractor vent, obscure glazed window to side aspect.

**Outside**

Rear garden - Mainly laid to paving and Cotswold stone, raised bed of plants and shrubs, further borders of plants and conifer, outside tap, wooden shed, brick walls and wooden fence, gate to side which provides access to front.
