

Offered with no upward chain is this bay fronted two bedroomed mid terraced property with a huge 150ft approx. rear garden that also has retained some original character features including internal doors tiled flooring. Further benefits include separate reception rooms, brick outbuilding, gas radiator central heating (new boiler fitted in May 2023) and uPVC double glazing. The accommodation briefly comprises entrance hall, lounge, dining room, rear lobby, kitchen, two bedrooms, bathroom, gardens to front and rear, brick outbuilding and outside WC.
