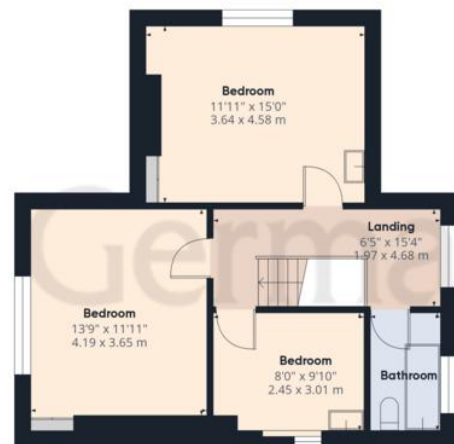








Ground Floor

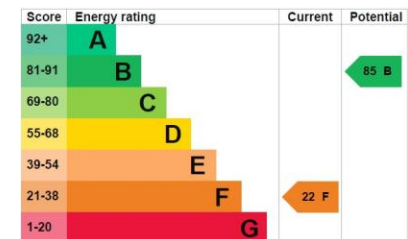
