Situated within ten minutes walk to the railway station is this vacant three bedroom terraced property which needs updating throughout yet benefits from gas radiator central heating, uPVC double glazing, built in kitchen appliances and a refitted shower room. The accommodation briefly comprises entrance hall, lounge, dining room, kitchen, two bedrooms, shower room and rear garden.

Comprising double drainer stainless steel sink unit with cupboards under, range of base and eye level units providing work surfaces, built in electric double oven and hob with extractor fan over, wall mounted gas fired boiler serving central heating and domestic hot water, window and door to side aspect, double radiator, understairs storage cupboard, plumbing for washing machine, space for fridge/freezer.
