## THE PROPERTY:

The accommodation comprises a door into the entrance hall with an airing cupboard off. Off to the right is a generous, well-proportioned living room which is dual aspect. The modern kitchen has a built-in oven and ceramic hob. Enjoying a pleasant aspect over the rear garden is a conservatory. There are two bedrooms, one with built-in wardrobe, and these are complemented by a bathroom.

## LOCATION:

The property is situated on the eastern fringe of the market town centre of Bridgwater, where junction 23 of the M5 can be accessed without passing through the town centre. There are local shops close by for day to day needs. The town centre of Bridgwater is approximately 1½ mile away and offers a full range of educational, leisure and retail facilities. Main line links are available via Bridgwater Railway station together with easy access to the M5 motorway via junction 23. There are regular bus services to Taunton, Burnham-on-Sea and Weston-super-Mare together with a daily coach service to London Hammersmith from Bridgwater bus station.
