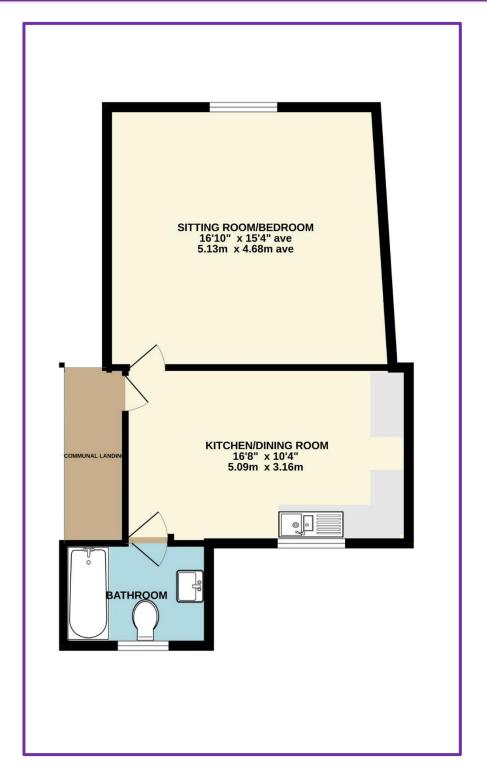

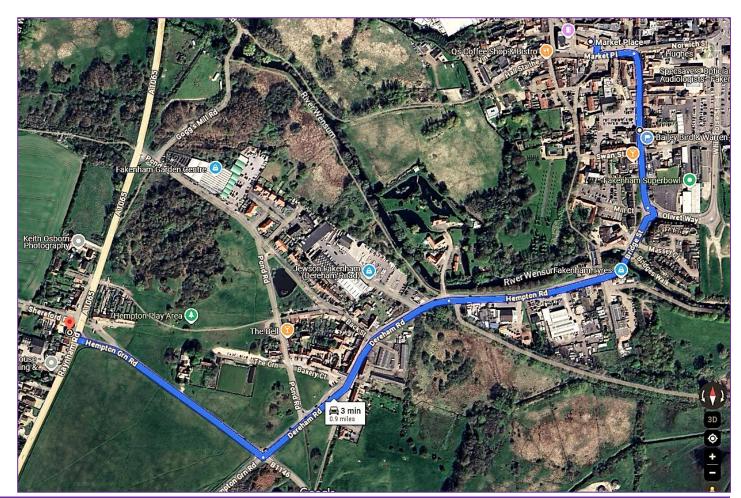


## **Directions:**
