This charming village pub enjoys a lovely central village location overlooking the brook. Coton in the Elms offers a pretty location with excellent countryside access and The National Forest. It is well placed for the nearby centres of Burton on Trent, Ashby de la Zouch, Tamworth and Lichfield.

With accommodation spanning three floors with the ground floor having a bar and games area and toilets. There is a kitchen, store and beer cellar together with a reception room.

The living space over the pub is currently used as two apartments, one with a kitchen, living/dining room and bathroom while the other has a living room, kitchen, bedroom, bathroom and loft bedroom with ensuite. (We understand this space has been converted but does not have the relevant building regulations or planning permission).

To the side and rear is the car park and pub beer garden, excellent outdoor space.

Solar panels have been added to enhance the energy efficiency of the building.

The change of use application was made 12th Decembar 2024 with expiration 3 years after this date ref – DMPA/2024/1350

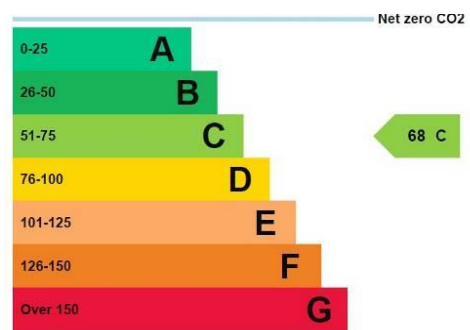
