Offered with no chain is this two bedroom detached bungalow situated in a cul de sac in the popular area of Gleneagles. The property benefits from uPVC double glazing, gas radiator central heating, built in kitchen appliances and further offers two double bedrooms, a 9ft brick and uPVC conservatory, a southerly facing 'L' shaped rear garden measuring approximately 61ft x 32ft extending to 63ft to the side, off road parking for three vehicles and a single garage with electric roller door. The accommodation briefly comprises entrance hall, lounge, dining room, kitchen, two bedrooms, conservatory, shower room, gardens to rear and side and a garage.


