



## Floor Plan

# **Description**

Rhode Lane is a three bedroom recently renovated mid terrace property, offered to the market with no onward chain and vacant possession.

#### THE PROPERTY:

The accommodation comprises an entrance hall, a lounge, kitchen and a bathroom. To the first floor are three bedrooms. The property is heated by gas fired central heating.

Outside - There is a garden to the front with a path leading to the front door. The garden to the rear is a good size and is fully enclosed and benefits from a full width covered area (constructed in 2023) which would be ideal all year round. The garden at the moment is being used for a large vegetable plot but could be easily put back to lawn to benefit from its size.
