Ideal for a first time buyer or investor is this three bedroom terrace which is local to the railway station and town and benefits from uPVC double glazed doors and windows, gas radiator central heating, a refitted kitchen and bathroom and a South facing rear garden. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, three bedrooms, bathroom and garden to rear.
