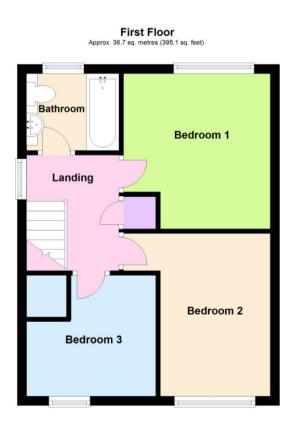

Offered with no chain is this three bedroom link detached house that is situated a short walk from the Redwell schools, shops and leisure centre. The garage has been converted to an additional reception room and the property also offers a utility room, cloakroom and 17ft refitted kitchen/breakfast room with built in appliances. Further benefits include gas radiator central heating, uPVC double glazed doors and windows and a refitted bathroom suite. The accommodation briefly comprises entrance hall, lounge, dining room, kitchen/breakfast room, utility room, cloakroom, three bedrooms, bathroom, gardens to front and rear and off road parking.
