Offered to the market with no upward chain is this mature bay fronted three bedroomed semi detached property situated upon a larger than average plot featuring a rear garden measuring approx. 150ft in length with the added benefit of a large wooden cladded and insulated summerhouse, large lean-to, gas radiator central heating and uPVC double glazing. The accommodation briefly comprises, entrance hall, lounge, dining room, kitchen, lean to, outside toilet, three bedrooms, bathroom, front and rear gardens, garage/workshop, summerhouse.
